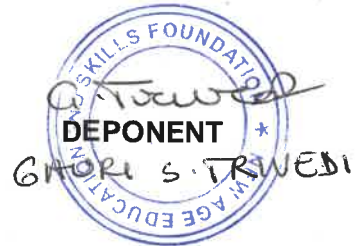
That the MoA/Rules shall be revised as per the existing UGC Regulations before the issuance of Notification by the Ministry of Education.

8. That the proposed Deemed to be University shall abide by all the provisions of the UGC Act, 1956 and the rules and regulations made under the said UGC Act including the UGC (Institutions Deemed to be Universities) Regulations 2023.


